

## **Limited Warranty**

Wamco, Inc. (WAMCO), warrants that its LIGEO<sup>™</sup> LED fixtures and accessories (the "Product") will be free from defects in materials and workmanship from the date of purchase for a period of 5 years.

WAMCO further warrants a Product lifetime of L70/B10 with an ambient operating temperature of 25°C.

## **Products under this Warranty include:**

LIGEO<sup>™</sup> SL, LIGEO<sup>™</sup> TW, LIGEO<sup>™</sup> SLC, and any derivative LIGEO<sup>™</sup> products which may be produced and sold by Wamco, Inc. in the future.

If a Product fails to operate during the warranty period as a result of defects in materials or workmanship, WAMCO will, at its discretion, repair or replace with the same or like Product at no charge. If the same or like Product is no longer available then credit for the original purchase amount of the Product will be provided.

To establish a claim under this limited warranty, WAMCO may require the return of the Product claimed to be defective to WAMCO's facility. All costs of transportation of the Product and of any repaired or replacement Product to or from WAMCO's facility shall be borne solely by the Buyer.

The cost of labor for removing a Product and for installing a repaired or replacement Product shall be the sole responsibility of the Buyer.

Any repaired or replaced Products, shall be covered under this warranty for the time period remaining under the original purchase warranty period or for a period of 90 days; whichever is longer.

**Original Purchaser:** This warranty is extended to the original Buyer only, with proof of purchase. However, in the event that valid warranty claims have been made to the original Buyer by its customers, WAMCO will honor those claims pursuant to the terms of its warranty as set forth herein.

**Terms and Conditions:** This Product warranty does not apply to failures caused by Acts of God or as a result of any improper or incorrect storage, use or installation of the Product, or any abuse, modification, misuse, unauthorized repair, unintended use, abnormal use or stress, or violation of any applicable standard, code or instructions, including without limitation, under voltage, under current, over voltage, over current conditions, excessive switching cycles or exposure to extreme ambient conditions outside of specified ratings.



Limitation of Liability: WAMCO in no way will be responsible at any time for labor costs, removal or installation costs, lost profits, indirect, incidental, special or consequential damages, decrease in the light output, and/or deterioration in the product's performance. The limited warranty expressly provided herein is the sole and exclusive warranty given by WAMCO with respect to the products. Any and all implied warranties, including warranty of merchantability and fitness for a particular purpose are expressly disclaimed to the extent permitted by law and, in any event, shall be limited to the warranty period specified above. Under no circumstances shall WAMCO's entire liability for a defective product exceed the purchase price of that product. Warranty services provided under these terms and conditions do not assure uninterrupted operations of products; WAMCO shall not be liable for damages caused by any delays involving warranty service.

## **Normal Operating Conditions and Cautions:**

IP Rating: IP20

• Temperature: +5°C to +40°C

• Relative Humidity: 5% to 90% (non-condensing)

- Do not install Product under direct air flow (e.g. from ventilation systems, etc.)
- Do not install Product near heat sources
- If Product is installed in a location where vibration is expected, special measures must be considered by the installer

**To Make a Warranty Claim:** Retain the failed Product(s) and invoice(s), and notify WAMCO in writing within thirty (30) days of the Product's failure. WAMCO will issue Return Material Authorization (RMA) and instructions prior to shipment of any failed Product to WAMCO.

**Applicable Law and Venue:** This warranty and all matters connected with the performance thereof shall be construed, interpreted, applied and governed in all respects by the laws of the State of California in the United States of America. Any action, suit or proceeding arising out of or relating to this Limited Warranty and/or to the purchase of Products covered by this Limited Warranty, shall be in the venue exclusively of the State or Federal courts located within the State of California (USA).

**Other Warranties:** No other terms, conditions or warranties with regard to the Product, expressed or implied, are authorized by WAMCO unless they are contained in a writing signed by a duly authorized officer of WAMCO.
